Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security with a minimum amount of Rs.3,90,000.00 (Three Lakh Ninety Thousand only) for the period of 90 days from 'A' Class Commercial Bank, which shall be valid for 30 days beyond the validity period of the bid **(120Days)**.
8. Pre-bid meeting shall be held on 26<sup>th</sup> November, 2021 at 2:00 pm at NATHM.
9. Electronic Bids shall be opened in the presence of bidders' Representative who chooses to attend at 13:00 Hours on 16<sup>th</sup> December, 2021 at the Office of NATHM, Rabi Bhawan
10. If the last date of submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
